Offers professional development in the arts and learning for educators in all disciplines. This program gives participants an opportunity to explore a variety of methods and mediums to develop ideas for lesson plans, curriculum, and teaching strategies.

Arts Education Institute Course Requirements and Credit

Credit: The course is offered for variable 1,2 or 3 credits. Each workshop session will be offered for 1 credit with a maximum of 3 credits offered.

Online/video workshops sessions 1- 4 are offered Monday-Friday from 8am-5pm. Each participant will choose one workshop per credit hour for the online live/video course

requirement. The participant can choose up to 3 workshop sessions for a total of 3 graduate credits.

ART 592 Students seeking to earn 1 undergraduate credit will:

1. Attend one online/video workshop session during the Online Arts Education Institute. July 13-17, 2020. 8am-5pm.
2. Sign into the online live/online registration link that indicates the student's attendance.
3. Complete and email the instructor of record nadya.prezler@northern.edu one lesson plan using the attached lesson plan template by July 30, 2020.
OR – Complete and email the instructor of record a one- page reflection paper and on how the student will incorporate what they have learned at the institute into the classroom or their artist practice no later than July 30, 2020.

Credit
