This is Alyce Morris Winston, Founder of the Jeffrey Foundation. As we celebrate 49 years of services to children with special needs and their families, my memory goes back to when I came here from Chicago, in the '70s with my son Jeffrey, and had no childcare for him here in Los Angeles! So, I started a program from my home, and now we have the Jeffrey Foundation which is serving the whole city of Los Angeles with childcare, after school programs, parenting programs and such. Now we are opening Special Child USA throughout the United States, by using remote services. Our teachers here at the Los Angeles area center (located on Washington Boulevard) are now providing remote services to all of our kids here in California. We'd like to spread this all over the United States! That's why Special Child USA is so very important, especially now with the Coronavirus still affecting all of us and keeping us in our homes. I will be sending letters to all of you in the United States and letting you know who in your state would be helping you with these remote services right in your homes. Even when school starts again, there will still be some other programs for you, and we would like to have your input.

Please let us know what would help you in your community when some of our teachers call you to see if you wish to have remote services. We are launching this program with a National Art Contest. Have your child show us what their "Circle of Love" looks like to them! Hopefully, they'll get busy at home creating art and then you can mail their finished piece to us or send us pictures by e-mail. Entries for this wonderful program will be taken between November 1 and December 31, 2020, with prize winners announced February 15, 2021! Please see enclosed application.
